- Acceptance will be for the low bid submitted by a responsible bidder.
- Optional consideration will be given for the trade in purchase by bidder for the Freeport Park District's 2013 Bobcat 5600 Toolcat with 2750 hours.
 - Award in this case will be total bid minus 2013 Toolcat trade in price. Lowest price after trade in.
